ON 05-17-11 AT 1315 HOURS, AND OTHER WITNESSES CAME TO THE DISTRICT 1 SUB-STATION WITH FOLLOW-UP INFORMATION AND REQUESTS FOR THIS CASE.

I INTERVIEWED IN THE DISTRICT 1 INTERVIEW ROOM. HE PROVIDED A DIGITALLY RECORDED, SWORN STATEMENT AS TO THE EVENTS THAT HE REMEMBERED OCCURRING AT THE TIME OF THIS INCIDENT. HE WAS SPECIFIC THAT HE MADE NO PHYSICAL MOVEMENTS OR THREATS TO THE SUSPECT, DAN RODIMER. HE DID NOT BELIEVE THAT DAN POSSESSED A WEAPON. SUSTAINED A VARIETY OF INJURIES FROM THE INCIDENT TO INCLUDE A CHIPPED TOOTH, BI-LATERAL FRACTURE OF HIS NOSE, A CUT LIP THAT REQUIRED STITCHES, SIGNIFICANT ABRASIONS TO MULTIPLE PARTS OF HIS HEAD, AND AN INTERCRANIAL HEMORRHAGE. THAT, WHEN CONTACTED BY THE ORIGINAL DEPUTY AT THE HOSPITAL, HE WAS IN A SIGNIFICANT STATE OF PAIN AND NOT OF SOUND MIND. AFTER TIME AND ENTERING INTO RATIONAL THOUGHT, HE DESIRES PROSECUTION ON THE SUBJECT WHO STRUCK
