
# Message #1

While he was in the Assembly, he received more money from the tobacco lobby than any other legislator and voted against legislation meant to crack down on financial crimes, trying to help big corporations and their wealthy CEOs get away with consumer fraud. Baugh-affiliated companies took nearly \$2 million in federal pandemic relief and never returned this money to taxpayers.

**Baugh In 1998: "I Do Not Support Abortion In Any Form."** "Baugh said he has always been staunchly antiabortion and only accepted the campaign money because the racetrack is in his district. 'It's like Ronald Reagan always said: 'They support me, I don't support them,'' Baugh said. 'The racetrack and its owner support me and my policies. I do not support abortion in any form.'" **2018: Baugh Opposed Abortion With No Exceptions For Rape Or Incest.** In 2018, Baugh appeared on a list of candidates that "uphold strong traditional family values, oppose the killing of preborn children for sex selection, convenience and birth control, and oppose assisted suicide and euthanasia. Evaluation is based on voting record, questionnaire response, and/or public statement." An asterisk next to a candidate's name denoted the candidate "accepts abortion for rape and/or incest." Baugh Voted For AB 2106. [California State Assembly, AB 2106, 5/5/98]

• AB 2106 Would Have Required An Ultrasound To Be Performed And That Ultrasound Be Shown To Patients Seeking An Abortion 24 Hours Before The Procedure. "This bill would require an ultrasound to be performed on a woman seeking an abortion within 24 hours prior to the abortion procedure, and would require the ultrasound to be shown to the woman prior to commencing the abortion procedure." #### Baugh Voted For AB 1758 In The Health Committee. [California State Assembly, AB 1758, 5/5/98]

• AB 1758 Would Have Required Doctors Performing Third-Trimester Abortions To Offer Information And Counseling On Fetal Pain And Fetal Anesthesia. "This bill would, for an abortion performed in the 3<sup>rd</sup> trimester of pregnancy, require the physician performing the abortion to offer to the pregnant woman information and counseling on fetal pain and offer to the pregnant woman anesthesia for the fetus. The bill would require the physician to arrange for anesthesia to be administered, if the pregnant woman voluntarily consents to administration of anesthesia for the fetus. The bill would require the pregnant woman to sign a document that information and counseling on fetal pain was provided and that the physician offered anesthesia for the fetus." The National Right To Life Committee Masterminded Model Legislation That Would Have Forced A 10-Year-Old Rape Victim To Give Birth, Then Said "We Would Hope That She Would Understand The Reason And Ultimately The Benefit Of Having The Child." "The 10-year-old Ohio girl who crossed state lines to receive an abortion in Indiana should have carried her pregnancy to term and would be required to do so under a model law written for state legislatures considering more restrictive abortion measures, according to the general counsel for the National Right to Life. Jim Bopp, an Indiana lawyer who authored the model legislation in advance of the Supreme Court's decision overturning Roe v. Wade, told POLITICO on Thursday that his law only provides exceptions when the pregnant person's life is in danger. 'She would have had the baby, and as many women who have had babies as a result of rape, we would hope that she would understand the reason and ultimately the benefit of having the child,' Bopp said in a phone interview on Thursday." Baugh Voted For AB 2389 In The Judiciary Committee. [California State Assembly, AB 2389, 4/21/98]

• AB 2389 Would Have Prohibited "Partial-Birth" Abortions And Fined Doctors Up To \$100,000. "This bill, notwithstanding the Therapeutic Abortion Act, would prohibit a person from knowingly performing or attempting to perform a partial-birth abortion, unless certain requirements in addition to the Therapeutic Abortion Act are met, including the requirement that the physician and surgeon reasonably believes that the partial-birth abortion was reasonably necessary to save the life of the pregnant woman and reasonably believes that no other procedure would suffice for that purpose. [...] The bill would provide that violation of the prohibition constitutes unprofessional conduct under the Medical Practice Act and would require the Division of Medical Quality of the Medical Board of California to impose a civil penalty of not less than \$10,000 and not more than \$25,000 for a 1st violation and not less than \$50,000 and not more than \$100,000 for a subsequent violation." Life At Conception Act: "This Bill Declares That The Right To Life Guaranteed By The Constitution Is Vested In Each Human Being At All Stages Of Life, Including The Moment Of Fertilization, Cloning, Or Other Moment At Which An Individual Comes Into Being." [H.R. 421, Introduced 1/20/23]

The Life At Conception Act Would Implement Equal Protection Of The Right To Life For "Each [...] Preborn Human Person." "To implement equal protection under the 14th article of amendment to the Constitution for the right to life of each born and preborn human person. [...] To implement equal protection for the right to life of each born and preborn human person, and pursuant to the duty and authority of the Congress, including Congress' power under article I, section 8, to make necessary and proper laws, and Congress' power under section 5 of the 14th article of amendment to the Constitution of the United States, the Congress hereby declares that the right to life guaranteed by the Constitution is vested in each human being." The Life At Conception Act Does Not Include Exceptions For IVF. "Most House Republicans have cosponsored a bill declaring that life begins from the moment of conception, a position under increased scrutiny after the Alabama Supreme Court ruled that frozen embryos are 'unborn children.' This Congress, 125 House Republicans — including Speaker Mike Johnson — have cosponsored the 'Life at Conception Act,' which states that the term 'human being' includes 'all stages of life, including the moment of fertilization, cloning, or other moment at which an individual member of the human species comes into being.' The bill does not include any exception for in vitro fertilization (IVF), a reproductive treatment that allows mothers to fertilize several eggs outside the womb in order to increase the chances of a viable pregnancy." 2001: After Leaving The Legislature, Baugh Joined Manatt, Phelps, And Phillips, A Lobbying Firm. "Former Assembly Republican Leader Scott Baugh of Huntington Beach, a pro at brokering deals with Democrats at the Capitol, has sealed yet another deal -- for himself -- at a law firm headed by a former Democratic national party chairman. 'It's not a big leap to work with Democrats,' said Baugh, who signed on with Manett [sic], Phelps and Phillips LLP in Los Angeles last month. [...] Baugh's new job, like his old one, will require weeknights in Sacramento. He'll be helping Orange County businesses, such as Affordable Housing Resources, put together a legislative package and figure out how to push their agenda. State law, however, prohibits Baugh from directly lobbying lawmakers on behalf of businesses for one year after he leaves office. Even though Baugh left public office in December because of term limits, he will continue to play a key role in rebuilding the state's Republican party, whose elected membership dropped by eight in both the state Legislature and Congress." Baugh Lobbied Against AB 523, Which Prevented Daystar, A Televangelist Network And One Of Baugh's Clients, From Purchasing Coast Community College District's PBS Station, KOCE TV. "As Gov. Arnold Schwarzenegger considers whether to sign a bill that could save the county's only public-broadcast television station, attention has centered on behind-the-scenes lobbying to derail legislation that would keep the station as a PBS affiliate. The lobbying raised some questions because it was led by county GOP chief Scott Baugh on behalf of Texas-based televangelist network Daystar Television. [...] Baugh declined to comment. The bill, AB523, would let the Coast Community College District sell the PBS station to its own foundation, rather than to the highest

bidder as state education code specifies. The Register has a joint marketing partnership with KOCE-TV. [...] After Daystar hired lobbyist Baugh and his company, Platinum Advisors LLC, Republicans -- even sponsors of the bill -- started pulling their support. 'I would say Scott was extremely effective at dissuading Republicans from voting for this bill,' said Assemblyman Tom Umberg, D-Santa Ana, a sponsor of the bill. 'They had about seven people out there lobbying.'" [Orange County Register, 9/28/06]

1996: Baugh Faced More Than 20 Criminal Charges, Including Felonies, Related To His Recruitment Of A Democratic Spoiler Candidate To Swing An Election

1995: Laurie Campbell Said She Was Running For Assembly To Represent Conservative Democrats. "In the most pivotal Assembly race in recent California history, at least one of the candidates is not necessarily competing to win. Laurie Campbell, a Democrat, says she got into the 67th Assembly District race because it appeared that four Republican candidates might split the vote, allowing the lone Democrat, Linda Moulton Patterson, to capture the conservative district in northwest Orange County. [...] Campbell said that she knows Baugh, whom she described as conservative, and that 'we share similar viewpoints' on most things. 'There is one conservative Republican,' she said, 'and I am a conservative Democrat.'" [Los Angeles Times, 10/19/95]

October 1995: The Los Angeles Times Reported "Rampant" Speculation That "Campbell Is A Republican Plant" To Split The Democratic Vote. "Talk has been rampant since the nomination period closed on Sept. 21 that Campbell is a Republican plant. Assemblyman Bill Morrow (R-Oceanside) told table mates at an Orange County Bar Assn. luncheon last week that Campbell 'is our candidate,' according to one lawyer there. Morrow, who backs the recall and has endorsed Republican Scott Baugh in the race, confirmed the remark but said it 'was based on rumor. I have no firsthand knowledge of it. . . . Obviously, as you gleaned, it would certainly benefit the Republicans to have more Democrats in the race." [Los Angeles Times, 10/19/95]

Baugh Initially Denied That He Knew Campbell At All. "Baugh's campaign maintains that he is the only 'solid conservative.' He has called Tillotson 'moderate to liberal' on social issues. Campbell said she plans on 'spending very little' in the race and does not expect to hire a campaign consultant. Baugh denied any association with her campaign. 'I had nothing to do with her candidacy,' he said. In an interview with The Times, Baugh at first denied even knowing Campbell. But Baugh amended his statement after a Times reporter noted that he and Campbell attend the same church and that Democrats are calling her a plant. 'I do want to clarify' the initial comment, he said. 'I do know Laurie and did know she went to Mariners. . . . I don't know why she is in that race.'" [Los Angeles Times, 10/19/95]

Laurie Campbell, The Democratic Spoiler Candidate, Testified That Baugh Was Also A Part Of The Scheme To Recruit A Democratic Spoiler Candidate To Swing The Election. "Assembly Republican leader Scott Baugh agreed Tuesday to pay a civil fine of \$47,900 for nine violations of the state Political Reform Act, ending a political misconduct case that began with Baugh's election in 1995. [...] In the settlement approved Tuesday, Baugh and Traxler agreed that they violated state campaign laws by illegally accepting an \$8,800 cash contribution from a Huntington Beach merchant and failed to properly report a \$1,000 contribution from the spouse of an eventual Democratic opponent. Baugh Voted Against Increasing Labor Protections For Workers In The Garment Industry, Such As Enforcing Punishment On Corporations That Withheld Payment From Employees. "In February 1999, Assembly Member Steinberg introduced A.B. 633 which revised statutes related to registration of garment contractors and manufacturers, as defined, the liability of such entities for violations of specified labor laws, and the collection of unpaid ages of workers employed in the garment industry. Specifically, the bill ensured that a person engaged in garment manufacturing who contracted with another person for garment manufacturing shall guarantee payment of wages and any damages and penalties arising from the failure to pay all wages due by the manufacturing. The bill provided that employees may enforce this guarantee by filing a claim with the Commissioner for payment by the guarantor. If the claim was not resolved within 60 days of filing, employees could bring a civil action against the guarantor. The bill also provided that the 10 largest shareholders of non-publicly traded corporations, as specified, shall jointly and severally be personally liable for all debts, wages or salaries due to owing to laborers who perform garment manufacturing for the corporation. Baugh Voted Against A Bill That Would Strengthen Law Enforcement's Ability To Investigate Financial Crimes. "In August 1998, Assembly Member Papan introduced A.B. 976 which specified that peace officers were allowed to testify about hearsay before a grand jury and changed the procedures for obtaining and disclosing specified utility, escrow, title and financial documents. The bill would except from the confidentiality provisions of the California Right to Financial Privacy Act the dissemination of financial information and records pursuant to a court order upon written application by a peace officer, under specified conditions relating to certain felony financial crimes. The bill also provided that utility records, escrow records or title records must be issued upon application by a peace officer showing reasonable cause to believe the information was relevant to an ongoing investigation of felony financial crimes. The bill's author, Assembly Member Papan, wrote that the bill provided 'California financial investigators and prosecutors with the necessary tools to effectively investigate and prosecute financial crimes. Baugh: NAY Bill passed with 61 AYES and 15 NOES "[A.B. No. 976, 8/25/98]
