"California will codify its progressive abortion protections in its state Constitution after voters overwhelmingly approved Proposition 1, a measure placed on the ballot in the aftermath of the U.S. Supreme Court's decision to overturn Roe vs. Wade. With its passage Tuesday, the state's Constitution will expressly guarantee a person's 'fundamental right to choose to have an abortion and their fundamental right to choose or refuse contraceptives." 2022: Gunderson Said That He Did Not Support Proposition 1 Because It Stripped Protections By Not Explicitly Banning Late-Term Abortions, "Allowing The Abortion Of A Scientifically Viable Life For Any Reason." "Q: What is your position on Proposition 1, which would establish the rights for Californians to an abortion and to contraceptives in the state Constitution? A: Let's start here: I am pro-choice. As the father to four daughters, protecting a woman's right to choose is very important to me. I'm in support of expanding women's health clinics, providing more affordable access to contraception, and establishing the right to choose and the right to contraception in the California constitution. What I do not support, and what the vast majority of Californians do not support, is the provision of Proposition 1 that goes beyond protecting the right to choose. [...] By not explicitly limiting late-term abortions, Proposition 1 strips these protections from California law, removing medical input and allowing the abortion of a scientifically viable life for any reason. Allowing these late, third-trimester abortions on demand would heighten risk of complications for the woman seeking the procedure, including permanent reproductive damage and death. What I do not support, and what the vast majority of Californians do not support, is the provision of Proposition 1 that goes beyond protecting the right to choose. In California today, it is legal to have an abortion for any reason up until fetal viability at about 24-26 weeks (six months). After that time, abortion is prohibited unless continuing the pregnancy risks the life of the mother. That means that abortion in

California is currently legal up until a doctor determines that either the fetus is a viable being who could live outside the womb or at any time if the life of the mother is at risk." [San Diego Union Tribune, 9/14/22]

"Again, we need to support the victims of incest, with love and compassion. It is possible that the victim's pregnancy gives her the first real chance of overcoming the family's denial and escaping from incest. Her pregnancy provides absolute proof of the crime of incest, while abortion adds to the young girl's sense of guilt and trauma, further covering up the crime and sending the victim back into an abusive home. Oftentimes, the victims of incest are pressured, forced into abortions by family members who are trying to hide the incestual relationship.
