- ✓ 2025: Tijerina supported an “overhaul” of the Affordable Care Act and called the ACA “a failure.”
- ✓ Nearly 4 million Texas, including more than 121,000 people in TX-28, were enrolled in Affordable Care Act marketplace plans in 2025.
 - *NOTE: The TX-28 number is based on the pre-redrawn district boundaries.*
- ✓ Repealing the Affordable Care Act would repeal protections for people with preexisting conditions and allow insurance companies to reinstate lifetime coverage limits on people and charge unlimited out-of-pocket costs for in-network care.

Tijerina Supported Trump’s Tariffs And Blamed Business Owners When Tariffs Increased The Price Of Goods And Disrupted Supply Chains In Laredo

- ✓ April 2025: Tijerina supported Trump’s tariffs and suggested they had not hurt South Texas.
- ✓ April 2025: Laredo Mayor Victor Trevino warned Laredo would be “impacted by the tariffs more than most communities.”
- ✓ April-August 2025: South Texas business leaders said tariffs would increase costs, disrupt supply chains, and hurt the trucking and customs industries.
- ✓ July 2025: Tijerina dismissed the impacts of “so-called tariffs,” and when a small business requested additional money from Tijerina’s County Court to cover increased costs, Tijerina said it was “their fault.”
- ✓ November 2025: When a contractor asked Webb County for a reimbursement to cover tariffs on equipment, Tijerina said “this tariff thing” had already come before the County Court and “it was not a tariff, it was just their way of making more money.”
 - ✓ Tijerina made air quotes around the word “tariffs” while suggesting a business was using the tariffs as a pretense to charge the county more money.
 - ✓ Webb County’s legal counsel said Webb County may be obligated to reimburse the contractor for extraordinary tariff costs.

Tijerina Intervened To Award An Exclusive County Contract To A Campaign Donor’s Company Despite The Company’s Bid Being Ranked 4th By The County Purchasing Agent

- ✓ Tano Tijerina intervened to award a contract for GPS systems for county sheriff patrol cars to a donor to his congressional campaign.
- ✓ October 2025: Tijerina motioned to award the Webb County GPS contract to Monarch Tracking, despite Monarch's bid ranking 4th by Webb County's own metrics.
- ✓ Monarch Tracking's CEO, Neal Hill, donated over \$3,000 to Tijerina's congressional campaign, including a large contribution just days before Tijerina motioned to award his company the contract, and promoted his candidacy online.
- ✓ July-October 2025: Hill donated over \$3,000 to Tijerina's campaign committee, with one donation just five days before Tijerina's motion.
- ✓ Hill made social posts indicating support for Tijerina's congressional campaign.
- ✓ In a public Webb County Commissioners Court meeting Tijerina praised Neal Hill's work when a County Commissioner pushed back on his motion to change the contract order.
- ✓ Tijerina encountered pushback from a fellow County Commissioner warning Monarch's bid could result in higher fees.
- ✓ Tijerina said this was perhaps only the third time he'd ever re-ranked a contract order in his eleven years as County Judge.
- ✓ Tijerina even said he knew CEO Neal Hill and praised his company's work as "really, really impressive" and "incredible."
- ✓ Tijerina stressed that Monarch Tracking's GPS technology would go on all 772 Webb County vehicles, no exceptions, when the county originally only sought GPS trackers for 50 sheriff's department patrol cars.
- ✓ Monarch Tracking ultimately secured the contract with Webb County.

A Complaint Was Filed Against Tijerina Alleging He Violated Federal Campaign Law By Using An Exploratory Committee To Skirt Texas' Resign-To-Run Law

- ✓ Texas had a resign-to-run law that Tijerina appeared to be intentionally and actively circumventing.
- ✓ Per Texas law, local Texas officeholders, including County Judges, automatically resigned their posts if they became a candidate for another office with more than 13 months left in their current term.
- ✓ Tijerina signaled his interest in running for Congress but said, "If I announce [for Congress], right now, today, I would lose my County Judge seat."
- ✓ Tijerina made public comments alluding to a congressional campaign announcement on December 1, 2025.
 - ✓ June 2025: Tijerina told Laredo-based outlet KGNS he could potentially announce his run for Congress after December 1, 2025.
 - ✓ September 2025: Tijerina told Houston-based radio host Kenny Webster he could "publicly come out" and announce his run on December 1, 2025.

- ✓ Tijerina told KGNS “everything is possible, I’m real to myself” when asked if there was a possibility he would decide not to run after his exploratory phase.
- ✓ An ethics professor filed a complaint before the FEC alleging Tijerina violated federal election law to protect his position as Webb County Judge.
 - ✓ An FEC complaint against Tijerina outlined statements from and actions by Tijerina that indicated he was using his exploratory committee as a way to circumvent resigning as Webb County Judge.

Tijerina Was Out Of Touch With Working-Class South Texans, Living On A \$7.3 Million, 152-Acre Estate That Had Multiple Houses, A Horse Ranch, And Various Wildlife

- ✓ 2001-2025: Tijerina registered the name “El Bosal” for business/professional purposes, was a registered agent and manager of El Bosal, LLC, and was registered to vote at the address of El Bosal.
- ✓ El Bosal was a 152-acre estate that had a main house, guest house, horse ranch, foreman’s house, and various wildlife, and was listed for sale at \$7.3 million.
 - ✓ Compass Real Estate touted El Bosal as “one of the most prestigious horse properties in South Texas” and “perfect for corporate entertainment, weddings, or private dinners” with 100 “closest friends.”
 - ✓ El Bosal’s main house was more than 8,000 square feet.
 - ✓ El Bosal had a five-car garage, a swimming pool with fountains, and a lighted basketball court.
 - ✓ The main house of El Bosal had a guest house with a game room and foreman’s house.
- ✓ Webb County had a median home price of \$250,000 and median household income of about \$62,000.

Tijerina Was A Political Opportunist Who Switched Parties From Democrat To Republican When It Was Convenient To Advance His Political Career

- ✓ 2014-2024: Tijerina was elected Webb County Judge as a Democrat three times and voted in Democratic primary elections as recently as 2024.
- ✓ 2024: Tijerina announced on Fox News he was switching parties from Democrat to Republican after Webb County flipped Republican in the presidential race for the first time in more than 100 years.

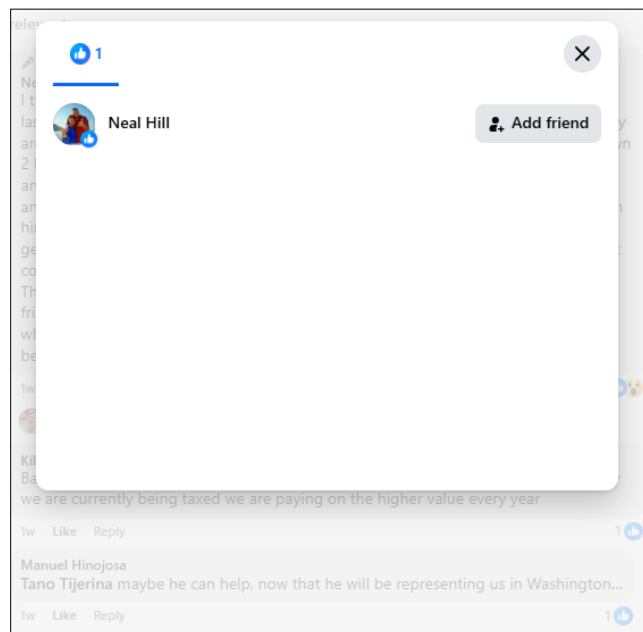
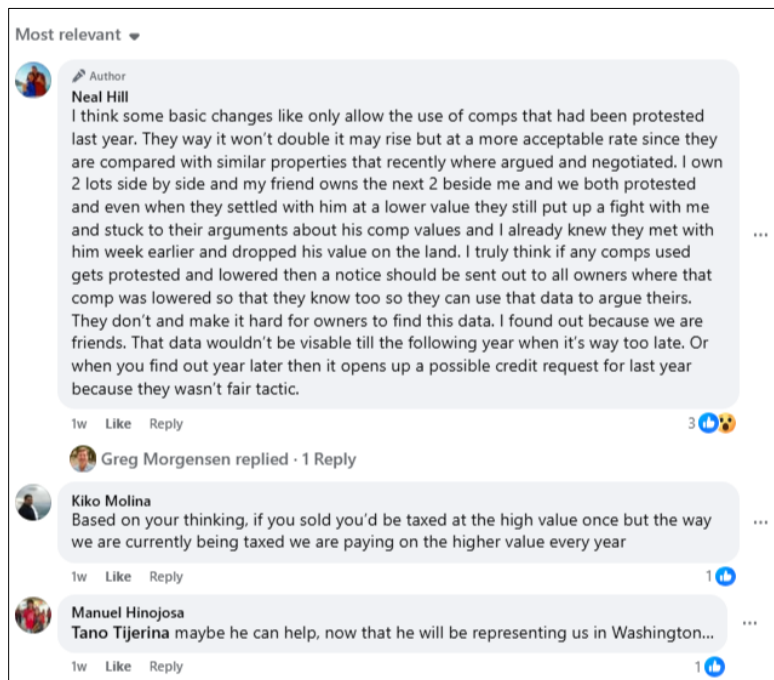

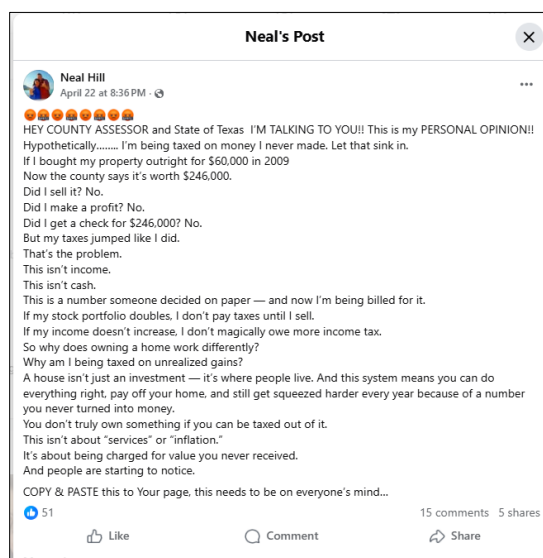

(a) This section applies to the following offices: District Clerks; County Clerks; County Judges; Judges of the County Courts at Law, County Criminal Courts, County Probate Courts and County Domestic Relations Courts; County Treasurers; Criminal District Attorneys; County Surveyors; County Commissioners; Justices of the Peace; Sheriffs; Assessors and Collectors of Taxes; District Attorneys; County Attorneys; Public Weighers; and Constables. (b) If any of the officers named herein shall announce their candidacy, or shall in fact become a candidate, in any General, Special or Primary Election, for any office of profit or trust under the laws of this State or the United States other than the office then held, at any time when the unexpired term of the office then held shall exceed one year and 30 days, such announcement or such candidacy shall constitute an automatic resignation of the office then held, and the

vacancy thereby created shall be filled pursuant to law in the same manner as other vacancies for such office are filled.” [Texas Constitution, [accessed 7/1/25](#)]

San Antonio Resident Cecilia Martinez, PhD, A Former Ethics Professor, Filed The Complaint And Added “If Judge Tijerina Is Willing To Disregard Federal Election Law Requirements Before Even Announcing His Candidacy, It Raises Serious Concerns About How He Would Conduct Himself If Elected To Federal Office.” “The complaint was filed Friday, Nov. 21 by San Antonio's Cecilia Martinez, Ph.D. ‘As someone who has taught ethics and decision making at Northern Kentucky University and worked as a journalist, I strongly believe

transparency is a non-negotiable,’ Martinez said. ‘A candidate who is evading that transparency obligation now undermines public trust and suggests a troubling pattern of behavior that may continue once in office. If Judge Tijerina is willing to disregard federal election law requirements before even announcing his candidacy, it raises serious concerns about how he would conduct himself if elected to federal office.’” [Laredo Morning Times, [11/23/25](#)]
