# Barbara Kirkmeyer (CO-08) Research Memo

### **Significant Findings**

Kirkmeyer Was A Swampy, Unethical Politician Who Sued The State To Cling To Her Cushy Government Job, Got Paid \$35,500 In Violation Of State Law, And Claimed Enough Mileage Reimbursements To Trigger An IRS Audit

- ✓ Kirkmeyer received special favors from former Governor Bill Owens—including contract changes to keep her job after Owens left office in 2007.
  - ✓ Kirkmeyer served in several positions in the Colorado state government—including as Director of the Division of Local Government and Deputy Director (later appointed Acting Director) of the Department of Local Affairs.
  - ✓ Kirkmeyer was notified by the incoming Ritter administration that her position as the Director of the Division of Local Government would expire.
  - ✓ Kirkmeyer sued the incoming Ritter administration and claimed that one of Owens' officials included a provision in her contract that allowed her to return to her job under the new administration.
- ✓ Kirkmeyer violated state law when she earned \$35,500 for writing grants for town governments less than six months after leaving her state government position.
  - ✓ The law stated that former state employees may not contract or be employed by employers who contract with a state agency six months following termination of employment.
- ✓ In March 2017, the IRS audited the Weld County government after the commissioners accumulated nearly \$50,000 in mileage expenses—Kirkmeyer claimed \$10,000 in mileage reimbursements.
  - ✓ In November 2017, Weld County was ordered to pay more than \$30,000 in late filing fees to the IRS after it was discovered that there were 59 payments to third-party vendors in 2015 that should have been issued 1099 forms.
- ✓ In June 2018, Kirkmeyer faced a recall campaign and was accused of several ethics violations—including selling personal property to Anadarko Petroleum which had been engaged in business with the county.
  - ✓ Kirkmeyer made \$158,333 from the sale of the property.
- ✓ The recall campaign accused Kirkmeyer of taking in travel reimbursements and municipal contributions and grants funding for personal use.
  - ✓ Between 2012-2014, Kirkmeyer claimed \$10,000 in mileage reimbursements.
  - ✓ According to Complete Colorado, as the President of the board of the South Platte Valley Historical Society Kirkmeyer, and one of her daughters, solicited donations from sponsors to host a craft fair but kept 20% of the donations as "commission."



• Kirkmeyer and her daughter exceeded the \$600 yearly threshold; no 1099s were given to either.

# Kirkmeyer Opposed Funding For Emergency Responders And Ambulance Services, Drawing Criticism From Local Law Enforcement

- ✓ After Kirkmeyer said the state would no longer support radio purchases by local governments, the Arapahoe County Sheriff criticized the decision as a "short-sighted approach to the state's No. 1 priority, interoperable communication."
- ✓ Kirkmeyer voted against approving University of Colorado Health's ambulance license request to allow the health care provider to use its ambulance service in Windsor, Severance, Johnstown, and Milliken.

### A Staunch Oil And Gas Supporter, Kirkmeyer Supported Efforts To Make It Easier To Drill On Residential Land And Limit Local Control Over Oil And Gas Regulations, And Fought Renewable Energy Sources

- ✓ Kirkmeyer voted in favor of rules that allowed oil and gas companies to drill residential areas without going through public hearings or getting landowners' sign off on proposed drilling plans.
- ✓ Kirkmeyer supported an oil drilling operation near a middle school in Greeley.
- ✓ Kirkmeyer opposed Senate Bill 181, which would change oil and gas regulations by prioritizing public health and safety and filed four ballot measures that aimed to roll back the bill's proposed changes.
- ✓ Kirkmeyer opposed allowing solar installations the same access to agriculturally zoned land that oil and gas drilling used, claiming regulations were needed to protect farmers from the solar industry.
- ✓ Kirkmeyer was named in lawsuit by a renewable energy firm filed against the Weld County Commissioners after they shut down the firm's plant.
  - ✓ According to the commissioners, Heartland Biogas broke almost 10 state and county rules, including air quality regulations and permitting infractions.
  - ✓ Dairy farmers claimed they depended on the plant to handle their farm's manure sustainably.

### Kirkmeyer Oversaw The Improper Use Of \$1.1 Million In Homeland Security Grants

- ✓ Federal auditors found state officials improperly spent \$1.1 million in grant money on rent for an emergency response center that the auditor believed had already been paid for.
- ✓ Kirkmeyer, the acting director of the Department of Local Affairs, claimed the audit was incorrectly based on a theory that the department was trying to purchase the office space.
- ✓ The state of Colorado repaid the \$1.5 million grant to the Department of Homeland Security.

### Kirkmeyer Was An Abortion Extremist Who Supported Banning Abortion Without Exceptions

- ✓ Kirkmeyer supported banning abortion without exceptions, even in cases of rape, incest or danger to the pregnant person's life.
- ✓ Kirkmeyer told the American Family Association she was a "proud and consistent supporter of the personhood movement."



- ✓ The American Family Association is a Southern Poverty Law Center-designated hate group known for their extreme anti-LGBTQ views, including blaming LGBTQ people for the Holocaust.
- ✓ Kirkmeyer supported defunding Planned Parenthood.
- ✓ Kirkmeyer voted to ban Plan B emergency contraception from Weld County-funded health clinics and said she still stood by that vote three years later.

# Kirkmeyer Supported Nullifying LGBTQ People's Marriages And Allowing LGBTQ People To Be Fired And Denied Service Based On Their Sexual Orientation Or Gender Identity

- ✓ In 2014, Kirkmeyer told the American Family Association's voter guide that she "strongly agreed" that the government didn't have the authority to allow LGBTQ people to marry.
- ✓ In 2020, Kirkmeyer told the American Family Association's voter guide that marriages between two people of the same gender should not be legal or supported with public funds.
  - ✓ Kirkmeyer said businesses should be able to deny services to gay couples and that educational institutions should continue receiving taxpayer funds if they banned students from marrying someone of the same gender.
- ✓ Kirkmeyer opposed adding sexual orientation, gender identity, and gender expression as protected classes in non-discrimination laws.

# Kirkmeyer Supported Repealing Colorado's Gun Laws And Declaring Weld County A "Second Amendment Sanctuary"

- ✓ Kirkmeyer said that repealing red flag laws was one of her top three priorities and opposed efforts to create red flag laws in the state.
- ✓ Kirkmeyer supported a resolution declaring Weld County a "second amendment sanctuary" that excused law enforcement officers from complying with red flag laws.
  - ✓ The resolution stated that the commissioners would support the sheriff if he decided not to enforce the Extreme Risk Protection Order bill and that funds would not be put toward building storage facilities for weapons seized by law enforcement.
  - ✓ The Extreme Risk Protection Order allowed law enforcement to seek the removal of a person's firearms if they were deemed to be at risk of harming themselves or others.
- ✓ Kirkmeyer voted against a law that required gun owners to report stolen or lost firearms.

### Kirkmeyer Was A Secessionist

- ✓ In 2013, Kirkmeyer said she supported Weld and several other counties in Northern Colorado seceding and forming their own state.
- ✓ Kirkmeyer voted to put the secession question on the ballot.
  - ✓ The ballot measure failed in Weld by 14 points, but Kirkmeyer still praised the effort.



### Kirkmeyer Was A Registered Lobbyist

- ✓ Between 2003 & 2004, Kirkmeyer was registered as a lobbyist in Denver, Colorado.
  - ✓ The address listed on Kirkmeyer's lobbyist summary, 1313 Sherman St RM 521, was associated with the Local Affairs-Local Government division of the Department of Local Affairs.
- ✓ In 2003, Kirkmeyer reported 71 hours of lobbying and didn't use any public fund for this lobbying activity.

Bill Ritter's hands in forming his own team by limiting the number of job openings his department heads could fill and by ensuring that Republican political appointees survive in a Democratic administration. Evan Dreyer, spokesman for Ritter, said the governor's office on Tuesday delivered letters to state departments notifying managers that the Ritter administration will not honor the job-guarantee provision." "Kirkmeyer's attorney argues that Owens' Department of Personnel and Administration executive director Jeff Wells acted properly when including the provision to allow Owens officials to return to state jobs under the new administration. Wells "had full power and authority to establish terms and conditions for contracting," the lawsuit claims. But Ritter officials said in February that the contracts violated personnel rules, and they would not honor them." [Denver Post, 9/6/07]

"A Weld County commissioner candidate has helped several Weld communities earn state grants, but the legality of her involvement in some of those processes is now in question. Weld District Attorney Ken Buck is investigating a complaint that Barbara Kirkmeyer, the Republican candidate for Weld commissioner District 3, violated a law that restricts recent state employees from contracting or being employed by someone who contracts with a state agency on certain matters." Kirkmeyer Offered To Help The City Pursue Grant Funds And Would Earn \$5,000 For Each Grant Awarded Worth \$50,000 Or More—Which Was Agreed To Less Than Three Months After She Left The Department Of Local Affairs. "Kirkmeyer offered to help the city pursue grant funds. The agreement outlined in the Sept. 26, 2007, council agenda indicates she would earn \$5,000 for each grant awarded worth \$50,000 or more. This was less than three months after leaving her position at the Department of Local Affairs." [Greeley Tribune, 9/26/08]

Kirkmeyer Said She Was Unaware The Law Existed And Helped Ten Weld Communities With Grants And Helped Gilcrest And Fort Lupton With Its Grants Prior To January 1<sup>st</sup>, 2008, When Her Six Month Constraint Expired. "Unaware that the law existed, Kirkmeyer said she has helped 10 Weld communities with grants and helped Gilcrest and Fort Lupton with its grants prior to Jan. 1, 2008, when her six-month constraint expired." [Greeley Tribune, 9/26/08]

• **Kirkmeyer Served As The Interim Town Administrator For Gilcrest.** "Kirkmeyer is running against Tom Petitt of Kersey for the district 3 seat on the county commission. She also serves as the interim town administrator for Gilcrest." [Greeley Tribune, 9/26/08]

Kirkmeyer Claimed She Did Not Violate State Law Because She Had No "Interest" In The Contracts And Only Writes The Grants For Town Governments. "However, Kirkmeyer believes she has not violated the statute because she has no "interest" in the contracts as the law states. Kirkmeyer said she doesn't sign the grants, lobby for the grants or talk to executive directors about the grants. She said she just writes the grants for the town governments." "When Garcia proposed striking Plan B – also referred to as the morning after pill – from county clinics' options for family planning, Kirkmeyer was the only commissioner to vote against the measure, but voted for it after their last discussion on the matter in July 2010. Kirkmeyer said in a interview on Tuesday that her initial concerns didn't revolve just around the availability of Plan B to low-income women, but on whether the county would lose state and federal funding for its clinics if commissioners stopped providing emergency contraception. After commissioners' third meeting, she said the funding aspect was worked out, and Wallace came back with a workable suggestion to refer women to places where they can get Plan B. 'I would say honestly, it was a 5-0 vote back in 2010, and I would still stick with that vote,' Kirkmeyer said." [Greeley Tribune, 2/6/13]
