Count 1

(Conspiracy to Distribute Controlled substances)

From on or about February 2019, and continuing through on or about April 2019, in the State and District of Minnesota and elsewhere, the defendants, SENIF JOBL GARZA, SARA RAE LAHR, and ROBERT EDWARD MALONEY, JR. did knowingly and intentionally conspire with each other and with others known and unknown to the grand jury to distribute 50 grams or more of actual methamphetamine, a controlled substance, in violation of Title 21, United States Code, Sections 841(a)(1), 841(b)(1)(A) and 846.

COUNT 4

(Possession with Intent To Distribute Controlled Substances)

On or about April 23, 20L9, in the State and District of Minnesota, the defendant, SENIF JOEL GARZA did knowingly and intentionally possess with intent to distribute 50 grams or

(Felon in Possession of Ammunition)

On or about April 23, 20L9, in the State and District of Minnesota, the defendant, SBNIF JOEL GARZA, having previously been convicted of the following crime, which was punishable by imprisonment for a term exceeding one year: ...and knowing he had been convicted of at least one crime punishable by imprisonment for a term exceeding one year, did knowingly possess, in and affecting interstate and foreign commerce, ammunition, that is, 8 rounds of Winchester .45ACP-caliber ammunition, and 25 rounds of Hornandy 9MM-caliber ammunition, all in violation of Title 18, United States Code, Sections s22(d[) and e24(a)(2).

PLEA AGREEMENT as to Senif Joel Garza, Index #98, filed 2/5/2021

Charges. The decedent agrees to plead guilty to Count 1 of the Superseding Indictment, which charges the Defendant with conspiracy to distribute 50 grams or more of actual methamphetamine, a controlled substance, in violation of 21 U.S.C. Sections 841(a)(1), 841(b)(1)(a) and 846. The Defendant fully understands the nature and elements of the crime with which he has been charged. At the time of the sentencing, the Government agrees to move to dismiss Count 4 and Count 5 of the Superseding Indictment.

MR. TEIRAB: Okay. I'm going to shift to the actual plea agreement and just summarize it and not hiding the ball at all. I'm functionally going to be reading from it, just to let you know. The plea agreement first in paragraph 1 specifies the charges, which are -- of the superseding indictment, Count 1, which you are agreeing to plead guilty, which charges you with conspiracy to distribute 50 grams or more of actual methamphetamine. Do you understand that that's in paragraph 1 of the plea agreement?

THE DEFENDANT: Yeah.

MR. TEIRAB: And you fully understand the nature and elements of that crime?

THE DEFENDANT: Yes, sir.

MR. TEIRAB: And in the agreement at the time of sentencing the government will agree to move to dismiss

Counts 4 and 5 of the superseding indictment. Do you understand that?

THE DEFENDANT: Yes, sir.

MR. TEIRAB: Okay. All right. I'm going to go through the factual basis, since that is in paragraph 2 here. In pleading guilty, you admit these following facts or that the government would be able to prove beyond a

reasonable doubt these facts. Do you understand that?

THE DEFENDANT: Yes, I do.

"Prison time ordered in fentanyl sales case," Mankato Free Press, 6/27/2024

A St. Peter man will serve prison time for drug sales in Blue Earth County.

Senif Joel Garza, 28, was convicted on a felony second-degree heroin/fentanyl sales charge Monday in Blue Earth County District Court.

Garza was one of two men charged in October after law enforcement reported seeing a suspected drug deal between the two in a fast food parking lot. The other man, Lincoln Alan Benzkofer, 29, of North Mankato, has a sentencing date set for Aug. 19 on a fentanyl possession charge.

Police reported finding 100 tablets of counterfeit oxycodone believed to contain fentanyl in Benzkofer's possession. A criminal complaint suggested Garza supplied the pills, with law enforcement tracking him down and arresting him after a pursuit.

Garza received a six-year, three-month sentence, minus 267 days credited to him for time already served, according to a sentencing order. He'd serve two-thirds of the sentence in prison followed by one-third on supervised release.
