Significant Findings

Williams Supported Letting Politicians Ban Abortion Without Exceptions, Criminalizing Reproductive Care Providers, And Funding Fake Women’s Health Centers

- ✓ Williams supported overturning Roe, allowing states to ban abortion without exceptions for rape, incest, or to save a woman’s life.
- ✓ January 2023: Williams endorsed federal, Republican-backed legislation that could criminalize reproductive care providers, including with jail time.
- ✓ Williams supported so-called “crisis pregnancy centers,” which are known for misleading women about reproductive health to discourage them from receiving abortion care.

Williams Wants To Gut Social Security And Medicare – Raising The Retirement Age, Privatizing Social Security, Replacing Medicare, And Potentially Eliminating The Programs Altogether

- ✓ September 2022: Williams called for increasing the retirement age for Social Security.
 - March 2024: When asked about raising the Social Security retirement age, Williams said, “[Y]ou have to be open minded about what kind of proposal that is.”
- ✓ 2016: While running for the U.S. Senate in Colorado as a libertarian, Williams said the libertarian platform calling for the elimination of any government program not outlined in the Constitution was “ideally [...] the best.”
 - When asked if she would support eliminating Social Security and Medicare as a result, Williams said, “I do believe minimum safety net for people but does that safety net have to be monopolized only by the provider which is called the government.”
- ✓ 2022: Williams called for replacing Medicare with a system where physicians groups would receive fixed monthly payments.

Williams Openly Embraced Trump And The MAGA Wing Of The Republican Party, Spread Conspiracy Theories About January 6th And The 2020 Election, And Antagonized The FBI

- ✓ Williams endorsed Trump’s 2024 reelection bid and called his conviction on 34 felony charges a “disgrace.”
- ✓ Williams repeatedly endorsed the “MAGA” label, saying, “MAGA is for everyone who loves America and wants to fight for her.”

- ✓ Williams elevated false claims that “antifa terrorists” were responsible for violence on January 6th and that the federal government allowed ballots to be cast in the name of deceased people in the 2020 election.
- ✓ Williams elevated the claim that the FBI was “Democrats [sic] KGB.”

Williams Opposed A Historic Law To Lower The Costs Of Prescription Drugs, Energy, And Health Insurance

- ✓ Williams opposed the Inflation Reduction Act (IRA).
- ✓ The IRA lowered prescription drug costs for seniors by capping insulin prices at \$35 and allowing Medicare to negotiate for lower prices.
- ✓ The IRA could lower household energy costs by \$1,800 annually and save ACA marketplace enrollees \$800 annually on health insurance premiums.

Williams Opposed The Affordable Care Act, Which Protected Granite Staters With Pre-Existing Conditions

- ✓ Williams said the Affordable Care Act (ACA) was “not about consumer choice” in 2016 and called an op-ed calling for its repeal “common sense” in 2017.
- ✓ The ACA introduced protections for individuals with pre-existing conditions; if it were repealed, 96,000 New Hampshire families would see premiums rise by an average of \$4,100.

Williams Repeatedly Pledged To Abolish The Department Of Education, Eliminating Billions In Education Funding, And To Defund Public Schools

- ✓ Williams repeatedly called to abolish the Department of Education; her campaign website called “to eliminate the federal Department of Education and repeal all federal laws regulating K-12 education.”
 - Abolishing the Department of Education would eliminate up to \$70 billion in federal education funding.
- ✓ Williams backed a bill to create a school voucher program in New Hampshire, which would defund public schools.

Williams Opposed The CHIPS And Science Act, Which Led To Major Investments In New Hampshire’s Technological Sectors

- ✓ Williams opposed the CHIPS and Science Act, calling it “corporate welfare.”

- ✓ The CHIPS and Science Act was expected to reduce inflation by investing in domestic supply chains and increase American competitiveness.
- ✓ The CHIPS and Science Act led to a \$35 million investment in Nashua's BAE Systems, which was expected to create new, good-paying jobs.
- ✓ The CHIPS Act included authorization for the tech hubs program; in October 2023, the ReGen Valley in Manchester received Tech Hub designation to compete for multimillion-dollar grants to improve technological competitiveness.

Williams Denied The Existence Of Climate Change And Opposed Measures To Mitigate It

- ✓ 2016: When asked if humans caused climate change, Williams said, "I'm not convinced either way."
- ✓ Williams opposed the Paris Climate Agreement, which she claimed would benefit Chinese state-owned enterprises.

2023: Williams Called LGBT Americans "Not Natural" And Claimed That LGBT Gen Zers Were "Being Used As Pawns For The Political Agenda"

- ✓ In April 2023, Williams posted a graphic showing how many Americans identified as LGBT, adding, "This is not natural. I feel sad & sorry for Gen Z. They are being used as pawns for the political agenda."

Williams Opposed Banning Guns At Schools And In Governments, Invoked The Holocaust To Justify Her Position And Uplifted Profanity Against A Survivor Of A School Shooting

- ✓ 2024: Williams called for eliminating "gun-free zones," and clarified that her position applied to schools and government buildings.
- ✓ April 2023: Williams suggested in an Instagram post that the Holocaust happened to Jews who "gave up their guns to their government" and called for eliminating gun-free zones.
- ✓ August 2024: Williams retweeted a tweet telling David Hogg, a school shooting survivor, to "suck that dick bitch."

Williams Opposed The Bipartisan Immigration Deal Endorsed By The Border Patrol Union After Trump Directed Republicans To Block It

- ✓ August 2024: Williams opposed the bipartisan immigration deal negotiated in the Senate.
- ✓ Trump directed Republicans to oppose the bipartisan immigration deal to avoid granting Democrats a political win.

- ✓ The bipartisan immigration deal was endorsed by the border patrol union and heralded as the toughest action on border security in decades if enacted.

2016: Williams Ran For The U.S. Senate In Colorado, Where She Lived For More Than Two Decades And Was Planning To Visit After The 2024 Election

- ✓ According to Williams, she lived in Colorado for 21 years.
- ✓ 2016: Williams ran for U.S. Senate in Colorado as a libertarian.
- ✓ August 2024: Williams tweeted that she planned to visit Colorado after the election.

Williams Supported Letting Politicians Ban Abortion Without Exceptions, Criminalizing Reproductive Care Providers, And Funding Fake Women's Health Centers

Williams Supported The Overturning Of Roe, Allowing States To Ban Abortion Without Any Exceptions

August 2022: Williams Supported Overturning Roe. “Tang Williams supports the recent Supreme Court ruling to send the question of abortion back to the states, allowing local voters to make their own decision. Tang Williams does not support any new federal law regulating or banning abortion, saying the matter needs to be left to the people in each state. ‘It should always belong to the states to let local people decide it,’ she said.” [NH Journal, [8/1/22](#)]

Overturning Roe Allowed States To Ban Abortion. “The Supreme Court on Friday stripped away women’s constitutional protections for abortion, a fundamental and deeply personal change for Americans’ lives after nearly a half-century under Roe v. Wade. The court’s overturning of the landmark court ruling is likely to lead to abortion bans in roughly half the states.” [Associated Press, [6/24/22](#)]

July 2022: The Atlantic: “Conservative States Are Rushing To Eliminate Or Narrow Existing Exceptions” To Abortion Bans Including To Save A Woman’s Life. “Even if someone believes that a fetus enjoys the same rights as an adult, abortion could be justified much in the same way that people who are anti-violence can understand the need in certain situations for self-defense. Support for the so-called life-of-the-mother exception seemed unshakable. Not anymore. Anti-abortion-rights groups, like Pro-Life Wisconsin, have described the ‘life of the mother’ exception as unnecessary and wrong. The Idaho GOP just approved a platform with no lifesaving exception. Republican candidates like Matthew DePerno, the Republican running to be Michigan’s attorney general, oppose all exceptions to abortion bans, and that includes to save a mother’s life. Conservative states are rushing to eliminate or narrow existing exceptions to their laws. Powerful groups like Students for Life, Feminists for Life, and the American Association of Pro-Life Obstetricians and Gynecologists (AAPLOG) argue that ‘abortion is never medically necessary’ and that doctors should always be punished for intentionally taking a fetal life.” [The Atlantic, [7/25/22](#)]

Gutmacher Institute: Trigger Laws In 12 States In The Event Roe Were Overturned Did Not Have Exceptions For Rape Or Incest. “12 states do not include exceptions for rape and incest in their bans that would be triggered if Roe were overturned or bans on abortions up to eight weeks of pregnancy: Alabama, Arkansas, Idaho, Kentucky, Louisiana, Mississippi, Missouri, Ohio, Oklahoma, South Dakota, Tennessee and Texas.” [Gutmacher Institute, [11/22/21](#)]

The So-Called “Born-Alive” Bill Would Penalize Doctors Who Violated It With A Fine And/Or Up To Five Years In Prison. “(b) Penalties.— (1) IN GENERAL.—Whoever violates subsection (a) shall be fined under this title or imprisoned for not more than 5 years, or both.” [Congress.gov, HR 26, Text, introduced [1/9/23](#)]

The Bill Would Establish Criminal Penalties For Doctors Who Did Not Follow Existing Federal Law Requiring Medical Care Be Given To Infants In The Very Unlikely Event Of A Failed Abortion. “Live births during an abortion procedure are exceedingly rare, experts said, and federal law already requires that a baby who survives an attempted abortion receive emergency medical care. The new bill would clarify the standard of care to which doctors are held and lay out penalties for violators. Policy organizations supporting abortion rights said the measure was an effort to discourage women from seeking abortions and doctors from performing them.” [New York Times, [1/11/23](#)]

HuffPost: The Bill Could Deprive Parents Of Holding Infants Who May Not Live Much Longer Or Limit Their Options For Medical Interventions. “This legislation could take away a pregnant person’s power to decide what medical interventions they want to receive during an already-emotional time, possibly forcing physicians to prolong an infant’s life for a short period of time before it dies. In certain cases, this could take away parents’ opportunities to hold their infants.” [HuffPost, [1/11/23](#)]

HuffPost Reported The Bill Is “Chock-Full Of Misinformation And Creates More Barriers To Care.” “The Born-Alive Abortion Survivors Protection Act, which passed 220-210 on Wednesday, would require physicians to provide life-sustaining care to infants born after an attempted abortion and threatens doctors with criminal penalties if they don’t comply. [...] But similar to other anti-choice legislation, the bill is chock-full of misinformation and creates more barriers to care. Reproductive rights advocates and physicians critical of the bill argue that it’s nearly impossible for infants to be born alive during abortions later in pregnancy. Bills like this are also redundant: Murder is already illegal in the U.S. If that’s not enough, the rights of an infant or newborn are already protected by a 2002 law that codified that infants have the same rights as any other human.” [HuffPost, [1/11/23](#)]

Williams Wants To Gut Social Security And Medicare – Raising The Retirement Age, Privatizing Social Security, Replacing Medicare, And Potentially Eliminating The Programs Altogether

2022: Williams Called For Raising The Retirement Age For Social Security

September 2022: Williams Called For Raising The Retirement Age For Social Security. “Starting in 2021, Social Security paid out more than it took in each year. Although the program has a multi-trillion-dollar surplus, a June report from the program’s trustees projected that without changes to the program, retirees and disabled people could see their benefits cut by 2035. In years past, those changes have included raising the retirement age — which now stands at 67 for those born in 1960 or later. Candidates’ proposals to shore up the program’s self-sustaining funding ranged from levying Social Security taxes on higher earners, to shifting to a flat benefit for all regardless how much individuals paid in, to scrapping the program entirely in favor of incentives for savings and investments. [...] Lily Tang Williams favors increasing the retirement age. She wants to see incentives for employer-sponsored 401(k) savings accounts, more private investment and more education about retirement planning.” [New Hampshire Union Leader, [9/11/22](#)]

March 2024: When Asked If She Would Support Raising The Retirement Age For Social Security, Williams Said, “You Have To Be Open Minded About What Kind Of Proposal That Is.” SEXTON: “The House Republican Study Committee just released several budget proposals. One of them is to raise the retirement age for Social Security. Are you on board with that?” WILLIAMS: “Oh, I have not studied that carefully because whenever they have these omnibus bills, it's always like, what? 1,000 pages for one day? It's like impossible to read it. I wish they would take time, not procrastinate so people can have a more open discussion, debate about that. And I do worry about our national debt. \$34 trillion now and every day we're paying down the national debt. Interest alone is \$2 billion per day. I just don't know how they're ever going to address that because young people tell me they feel like they have no future and they cannot afford anything and they're worried about their American dream. So I hope that I can address that when I get elected.” SEXTON: “And so, but the idea of, you know, raising the retirement age for younger people in Social Security later. Is that an idea you would support?” WILLIAMS: “Well, if that's the only way we can keep Social Security solvent because right now, you know, some people say we might run out of, you know, money. There's no lockbox and government spends it all. So you depend on future generations' money working to, you know, support the retirees and so you have to be open minded about what kind of proposal that is, you know.” [WMUR, 1:32, [3/24/24](#)] (VIDEO)

2016: Williams Suggested She Was Open To Privatizing Or Eliminating Medicare And Social Security Altogether, And That Younger Workers Should Be Able To “Opt Out” Of Social Security

2016: Asked About The Libertarian Platform Calling For Repealing Federal Programs Not Delineated In The Constitution, Williams Said, “Ideally That’s The Best, The Libertarian Society I Could Imagine To Live In.” “Warner: Let's turn to the philosophy of your party, the Libertarian Party. We have posted a link to the party platform at CPRnews.org. It calls for repealing ‘All federal programs and services not required under the U.S. Constitution,’ that document you read back in China. Do you agree with that idea of eliminating all of those programs, all of those services not specifically mentioned in the document? Tang Williams: Well ideally that's the best, the Libertarian society I could imagine to live in. Its government is very small, limited by the Constitution and people voluntary help their communities, private charities and take care of their own people. That would be best way. Nobody wants to be forced by government to say got to do this. But when you believing a cause, you pull your strengths, your resource together to help each other. I thought that would be the best way and you would feel so good and so rewarding from the experience instead of being forced.” [Colorado Public Radio, [9/8/16](#)]

Asked If She Would Eliminate Medicare And Social Security In A Follow-Up Question, Williams Said, “I Do Believe Minimum Safety Net For People But Does That Safety Net Have To Be Monopolized Only By The Provider Which Is Called The Government.” “Warner: This would do away with, gosh, the entire federal safety

net. You're talking Social Security, Medicare, Medicaid, food stamps. I guess you're saying the idea is that the private sector is the safety net or would you leave it up to states to perhaps create? Tang Williams: Well I think, I do believe minimum safety net for people but does that safety net have to be monopolized only by the provider which is called the government and how did Americans survive before the big federal government involved in all their sectors? I learned in American history people were independent, self-responsible but also working very hard to better their lives. Williams Continued On To Say Younger Workers Should Be Able To “Opt Out” Of Social Security. “Tang Williams: Well I agree there. Those programs were created with good intentions but good intentions do not create desirable outcome. I would think that, to look at our government today, what is causing our country so broke today with almost \$20 trillion in debt and our kids, grandchildren are going to pay for that. So I would actively look at a program to see where we could be reformed to make it more efficient or to replace with something like, for example, if you're under 30, maybe you could opt out a program, save on your own because I do trust our individual citizens are smart enough to take care of themselves and to actually build a safety net themselves. Warner: Help me understand that, if you're under 30, what would you do? Tang Williams: They could opt out, like for example Social Security, because our Social Security is totally broke. The lock box does not exist, government spend all the money you put in so it's the new generation now paying for the people who are retired on Social Security income today. So it's like almost like some kind of investment scam like [Bernie] Madoff. The money's not there. It's a new investor come in to pay for the old investors on their returns and on their income. During Her 2020 Primary Campaign, Boebert Said, “Everything That I've Heard Of Q, I Hope That This Is Real,” Then Said She Disavowed The Theory After Her Primary Election. “Boebert appeared on SteelTruth, a show hosted by QAnon believer Ann Vandersteel, during the primary campaign. In that interview, she said she was ‘very familiar’ with the theory and voiced support for it, though she didn't say she fully believed in QAnon's ideas. ‘Everything that I've heard of Q, I hope that this is real, because it only means America is getting stronger and better, and people are returning to conservative values, and that's what I am for,’ she said. ‘And so everything that I have heard of this movement is only motivating and encouraging and bringing people together stronger, and if this is real, then it could be really great for our country.’ NPR asked Boebert's campaign about her views on QAnon. Her campaign responded with a statement from the candidate: ‘I'm glad the IG and the AG are investigating deep state activities that undermine the President. Boebert Insinuated Rep. Ilhan Omar Was A Terrorist Multiple Times. “Boebert, who lives in Garfield County, has been facing intense criticism since a video was posted online last week showing her speaking at an event and describing an interaction with Minnesota Democratic U.S. Rep. Ilhan Omar. In the video, Boebert claims that a Capitol Police officer approached her with ‘fret on his face’ shortly before she stepped aboard a House elevator and the doors closed. ‘I look to my left and there she is — Ilhan Omar. And I said: ‘Well, she doesn’t have a backpack. We should be fine,’” Boebert says with a laugh. Boebert’s comment about Omar not wearing a backpack was an apparent reference to her not carrying a suicide bomb. June 2022: The Day Roe Was Overturned, Boebert Said, “I Am Tired Of This Separation Of Church And State Junk. It's Not In The Constitution.” “On the Sunday after the Supreme Court reversed a decades-old ruling that legalized abortions in the U.S., Republican congresswoman Lauren Boebert spoke to a crowd at a church in Colorado. Among other things, Boebert complained that faith communities have long had to deal with laws in the U.S. that they don't agree with. ‘The church is supposed to direct the government,’ she said. ‘The government is not supposed to direct the church. That is not how our founding fathers intended it. And I am tired of this separation of church and state junk. 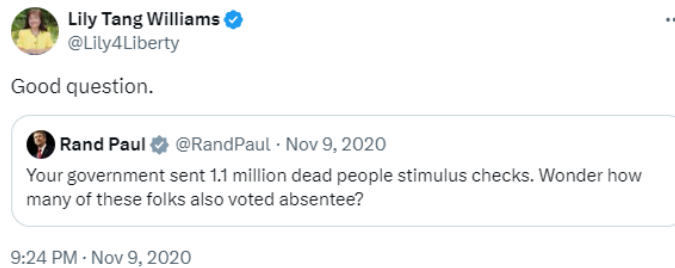

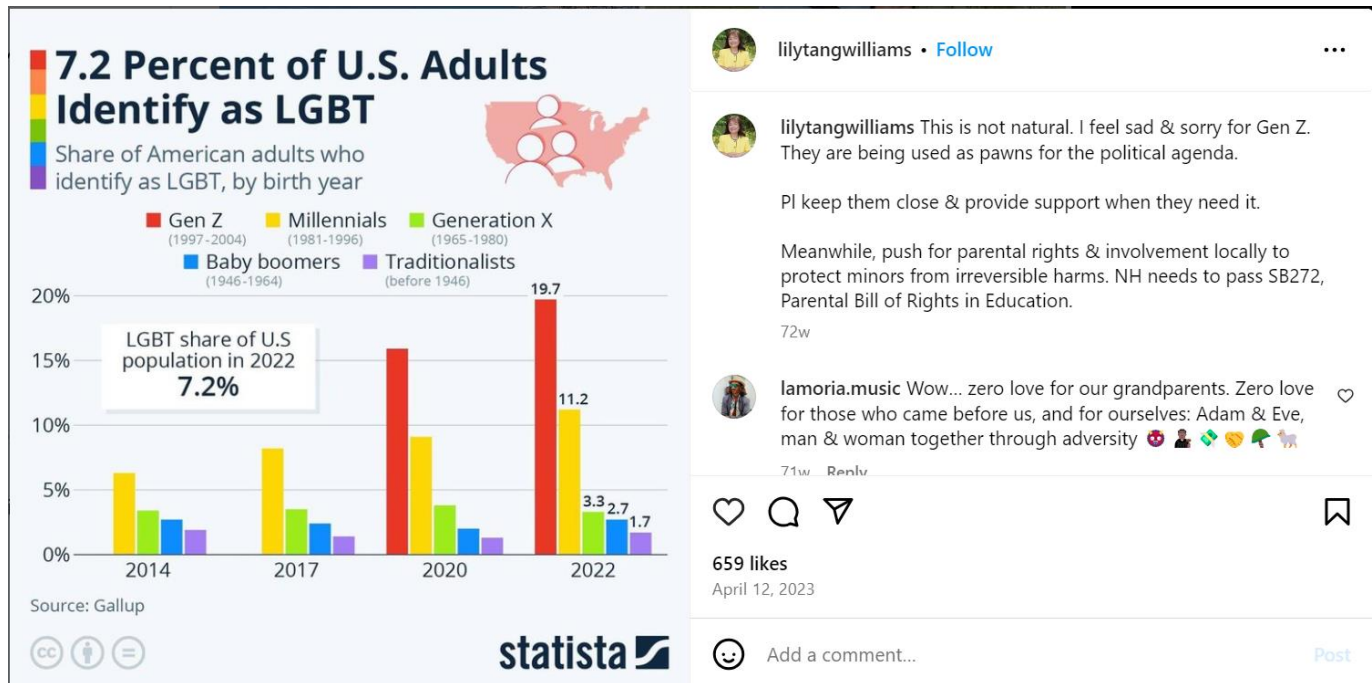

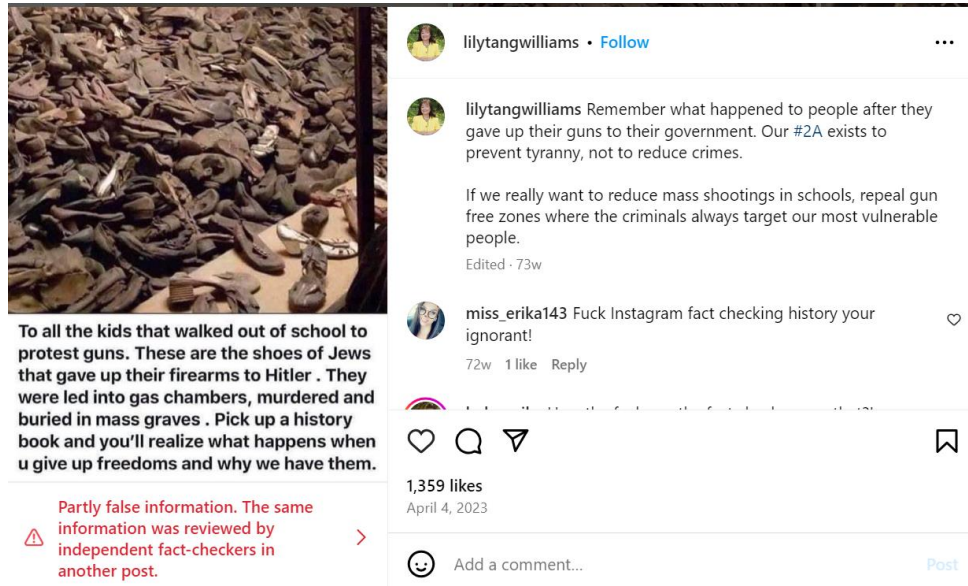
