The One Big Beautiful Bill Did Not Extend Enhanced Premium Tax Credits For ACA Marketplace Plans. “The OBBBA did not extend enhanced premium tax credits for ACA marketplace plans. As a result, when open enrollment begins on November 1, 2025, 20 million marketplace enrollees will see their premium costs spike.” [Center for American Progress, [7/29/25](#)]

- **Bridge Michigan: The Average ACA Plan's Cost Would Rise By 30%.** “With less than two weeks until open enrollment starts, thousands of Michigan residents face a triple challenge. Members of Congress have been wrangling over a temporary spending plan, and whether it will include an extension of an ‘enhanced’ ACA premium tax credit benefiting millions of Americans. [...] Whether covered by ACA or an employer, Michigan residents can expect to pay more for health insurance in 2026, according to the rate requests insurers submitted over the summer to the Michigan Department of Insurance and Financial Services. 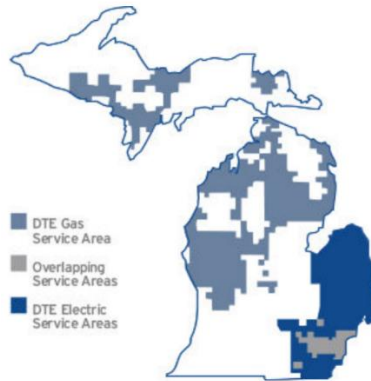

“During the 2022 election, Michigan voters approved a measure enshrining abortion rights and protections for reproductive freedom within the state Constitution, offering residents a safeguard in the wake of the federal Supreme Court’s decision to strike down Roe v. Wade, leaving abortion regulation to the states. While proponents of reproductive freedom celebrated the proposal’s success and the subsequent repeal of the state’s abortion ban, several anti-abortion advocates filed a case in federal court, arguing the amendment to the state constitution violated several provisions of the federal charter. However, that challenge was dismissed on Tuesday by Judge Paul Maloney of the U.S. District Court Western District of Michigan’s Southern Division. The plaintiffs – which include Right to Life of Michigan, state Reps. Gina Johnsen (R-Portland) and Luke Meerman (R-Coopersville) and state Sen. Joseph Bellino (R-Monroe) among other abortion opponents – argued the measure reduces legal protections for women, deprives parents of the ability to make decisions about medical treatment for their
