[...] How Project 2025 plans to misapply Comstock to effectuate a national abortion ban Although the term ‘Comstock’ is not directly used in Project 2025, it is referenced by statute on p. 594 of Project 2025’s Mandate for Leadership: Announcing a Campaign to Enforce Criminal Prohibitions in 18 U.S. Code §§ 1461 and 1462 Against Providers and Distributors of Abortion Pills That Use the Mail. Federal law prohibits mailing ‘[e]very article, instrument, substance, drug, medicine, or thing which is advertised or described in a manner calculated to lead another to use or apply it for producing abortion.’ Following the Supreme Court’s decision in Dobbs, there is now no federal prohibition on the enforcement of this statute. The Department of Justice in the next conservative Administration should therefore announce its intent to enforce federal law against providers and distributors of such pills. The Comstock Act commonly refers to a set of two anti-obscenity laws that are officially codified as 18 U.S.C. 1461 and 1462, with the U.S. Postal Service charged with its enforcement. Notably, Comstock has never been used to prosecute the mailing of abortion-related materials. Even though decades of judicial, congressional, and agency interpretation have reduced Comstock to an unenforceable relic, ultimately, far-right extremists plan to avoid the legislative process entirely and misapply the law to criminalize the mailing of items related to abortion in the mail.” [Center for American Progress, Article, [6/17/24](#)]

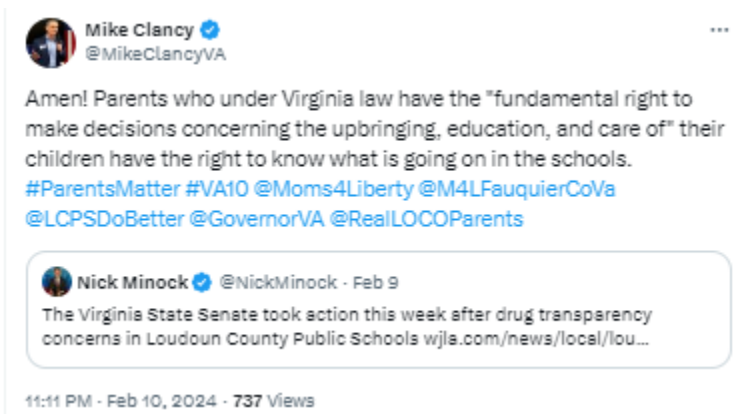
