He votes with his party and supports Trump’s priorities the vast majority of the time, though he’s broken with them in instances like the final passage of the One Big Beautiful Bill and the expiration of COVID-era Affordable Care Act tax credits that kept costs lower for individuals using the public marketplace. Those funding reductions do not disappear - they shift the burden to states, facilities, and families. States now face an impossible choice: raise their own revenue, cut Medicaid services, tighten eligibility requirements, or reduce how much they reimburse nursing homes for each resident's care. Some states have already indicated lower Medicaid provider rates or are considering cuts heading into the 2026-2027 fiscal year, with further pressure expected in 2027. For families of nursing home residents, this translates into real and immediate risk. Facilities operating on reduced Medicaid reimbursements may cut staffing hours, reduce therapy and activity programs, delay maintenance and safety repairs, or - in the worst cases - close entirely. ### **March-April 2026: Fitzpatrick Voted Twice To Continue The War In Iran**

**April 16, 2026: Fitzpatrick Voted Against The Iran War Powers Resolution.** In April 2026, Fitzpatrick voted against: “Passage of the concurrent resolution that would direct the president to terminate the use of U.S. armed forces from hostilities against Iran unless explicitly authorized by a declaration of war or specific authorization for use of military force against Iran. The measure would exempt the use of U.S. armed forces that may be necessary to defend the U.S. or a U.S. ally or partner from imminent attack.” The bill was rejected by a vote of 213-214. **March 5, 2026: Fitzpatrick Voted No On Removing The U.S. Armed Forces From Unauthorized Hostilities In Iran.** On 3/5/26, Fitzpatrick voted NO on “H.Con.Res.38 - Directing the President pursuant to section 5(c) of the War Powers Resolution to remove United States Armed Forces from unauthorized hostilities in the Islamic Republic of Iran.” The bill failed in the House 212-219. - **The War Powers Resolution Would Have Required President Trump To Obtain Congressional Authorization For His Air War In Iran.** “The U.S. House of Representatives rejected an effort on Thursday to stop President Donald Trump's air war on Iran and require that any hostilities against Iran be authorized by Congress, backing the Republican president's military campaign on the sixth day of the expanding conflict. The vote was 219 to 212, largely along party lines, in the House, where Trump's fellow Republicans control a narrow majority of seats. Two Republicans voted in favor of the resolution and four Democrats voted against it. [...] Supporters said the resolution, by requiring Trump to come to Congress for a war authorization, would force him to explain to Americans why the U.S. is fighting and how it might end.” [Reuters, [3/6/26](#)]

**July 2026: The Iran War Cost \$37.5 Billion According To Defense Secretary Pete Hegseth.** “The cost of the United States' war in Iran has risen to \$37.5 billion so far, U.S. Defense Secretary Pete Hegseth said on Tuesday, as he faced skeptical lawmakers for the first time since heavy bombings resumed to seek urgent funding for the unpopular conflict.
