Luna Voted Twice For The One Big Beautiful Bill, Which Gave Tax Breaks To The Richest Americans

2025: Luna Voted Twice For The One Big Beautiful Bill

July 2025: Luna Voted For The One Big Beautiful Bill Act. In July 2025, Luna voted for: "Motion to concur in the Senate amendment to the bill that would permanently extend nearly \$4 trillion in expiring individual and business tax cuts, create several new tax breaks and fund border and immigration enforcement and air traffic control upgrades. It would cut Medicaid and other safety net programs to partly offset the cost. Among other provisions, it would raise the statutory debt ceiling by \$5 trillion and

appropriate more than \$448 billion in mandatory funding for Trump administration priorities and other needs, including \$153 billion for defense, \$89 billion for immigration enforcement, and \$89.5 billion for border control and security. It also would increase the state and local tax deduction cap to \$40,000 annually for five years for households making up to \$500,000 a year until 2030, when it would permanently revert to \$10,000.” The motion was agreed to by a vote of 218-214. May 2025: Luna Voted For Cutting Net Taxes By Approximately \$3.8 Trillion And Reducing Spending By \$1.5 Trillion As Instructed In The Fiscal 2025 Budget Resolution. In May 2025, Luna voted for “Passage of the bill that would provide for approximately \$3.8 trillion in net tax cuts and \$321 billion in military, border enforcement and judiciary spending, offset by \$1.5 trillion in spending reductions, as instructed in the fiscal 2025 budget resolution (H Con Res 14). It would raise the statutory debt limit by \$4 trillion and provide for increased spending on defense and border security, spending cuts on social safety net programs, such as Medicaid and the Supplemental Nutrition Assistance Program. It also includes a mix of tax breaks for businesses and individuals; tax increases on universities and foundations; and a phase-down of clean energy tax credits. It would reduce spending on Medicaid by \$625 billion over a 10-year period and modify eligibility and cost provisions for enrollees and health providers and impose work, volunteer and education requirements on adults ages 19 to 64 who are covered by the program. It would appropriate “such sums as necessary” for reducing cost-sharing payments for low-income individuals who’ve purchased “silver” plans on the 2010 health care law’s exchanges. But payments to plans that cover abortions would be mostly barred. It would extend and make permanent individual tax brackets and rates included in the 2017 tax overhaul law (PL 115-97) and provide for the adjustment of the lower bounds of each tier based on inflation. It would reduce federal spending on the Supplemental Nutrition Assistance Program by requiring states to shoulder more of the cost, expand work requirements for SNAP, extend programs authorized under the 2018 farm bill, and prohibit the U.S. Department of Agriculture from increasing the cost of the Thrifty Food Program. As amended, it would cap state and local tax deductions at \$40,000 for households with incomes below \$500,000 and prohibit Medicaid funding for gender transition therapies or procedures for minors and adults, among other provisions.” The bill passed by a vote of 215-214. The One Big Beautiful Bill Would Give The Richest 5% Of Americans More Than \$1.5 Trillion In Tax Cuts

Center for American Progress: “Under This Proposal, Millionaires Would See A Larger Tax Cut Than The Bottom Half Of Americans Combined—With More Than \$1.5 Trillion In Tax Cuts Going To The Top 5 Percent.” “The One Big Beautiful Bill Act would issue the largest transfer of wealth from working-class Americans to the ultrawealthy in the nation’s history. To do so, House Republicans are proposing to cut programs that are essential to people, especially in states that voted for Trump in the last election, in order to pay for tax cuts for the wealthiest Americans. Under this proposal, millionaires would see a larger tax cut than the bottom half of Americans combined—with more than \$1.5 trillion in tax cuts going to the top 5 percent. In total, households that make at least \$1 million per year would receive roughly twice as much in tax breaks as the bottom 50 percent of the nation combined. Roughly 57 million households in the bottom 60 percent would see a tax increase or a negligible tax change (\$100 in either direction) under the House Republican proposal. Not only does this proposal extend the 2017 Tax Cuts and Jobs Act’s tax breaks for the wealthy, but it also adds additional loopholes that skew the tax code even more in favor of the ultrawealthy. The One Big Beautiful Bill Would Increase Income Inequality, With Low-Income Americans Feeling The Effects Of Aid Cuts And The Wealthy Seeing Most Of The Tax Gains

Washington Center For Equitable Growth: The Federal Budget Bill's Spending Cuts To Benefit Programs Would Increase Inequality. "Similar to the tax cuts they help finance, the bill's spending cuts are guaranteed to substantially increase inequality. They share another feature, too: These are complex changes to policy details that few Americans recognize or understand. Indeed, many involve the imposition of new administrative burdens on people who receive or apply for public benefits at the state level. There is only one way that regressive spending cuts can free up \$1.3 trillion to finance regressive tax cuts: by taking away valued benefits from tens of millions of Americans." The Budget Lab: The Bottom 10% Of American Households By Income Would See An Average Reduction In Incomes, While Those At The Top Would See An Increase Due To The Combined Effects Of The Reconciliation Bill And Tariffs. "The Budget Lab has previously estimated the net budget impact of combining the OBBBA and recent increases in tariffs. Conventionally scored, OBBBA costs \$2.4 trillion as written (\$4.0 trillion if the temporary provisions become permanent). The tariffs implemented as of June 1 would raise \$2.4 trillion. A natural follow-up question is: what is the net distributional impact of both the OBBBA and tariffs? This report answers that question by incorporating tariffs into CBO's distributional estimates of the OBBBA. Our tariff estimates, which reflect the Trump Administration's 2025 tariff increases this year through June 1, are based on prior TBL analysis and are adjusted to match the income concepts in CBO's report. [...] The results of this exercise are shown in Figure 1, which reports average annual changes to after-tax-and-transfer income over the 2026-2034 period. We find that the combination of OBBBA and 2025 tariffs would reduce resources on average among the bottom 80 percent of households. The bottom ten percent of households would see an average reduction of more than 6.5 percent in incomes, while those at the top would see an increase of nearly 1.5 percent." "It took intense lobbying from President Donald Trump, an all-nighter, and a vote on a bill for which many people did not yet have a clear grasp of the final changes, but House Republicans got it done this week. They passed their version of the 'one big, beautiful bill,' a behemoth that pairs tax cuts with new provisions that will push people off Medicaid and food assistance. Low-income Americans will feel the effect of changes to aid programs, while the wealthy will see most of the windfall from tax cuts, according to multiple assessments. [...] Higher-income taxpayers would come out ahead, with 60% of the tax cuts going to the top 20%, who have incomes of at least \$217,000, next year and more than a third going to the top 5%, or those who earn \$460,000 or more, according to the center. The following numbers show how the rich would get the biggest boost in their after-tax income compared to others. Those in the top 20% would see an average tax cut of \$12,660 next year, increasing their after-tax income by 3.4%. But again, that's compared with current law, in which Trump's first-term tax cuts are expiring. Middle-income earners, those making between about \$67,000 and \$119,000, would get a tax break of \$1,840, bumping up their after-tax income by 2.4%, while those in the lowest bracket, who earn less than about \$35,000, would get a tax cut of \$160, nudging up their after-tax income by 0.8%." Though estimates vary, the share of wealth that comes from inheritances also is large: On the lower end, more than one-third of wealth is inherited among U.S. households, and high estimates put the share closer to two-thirds. Rather than strengthening a key policy tool that could reduce the ability of dynastic wealth to be transferred across generations, the Republican tax bill follows a trend that began at the turn of the 21st century. Dramatic increases in the estate tax exemption threshold have resulted in an infinitesimally small fraction of the nation's wealthiest individuals facing any liability at all." 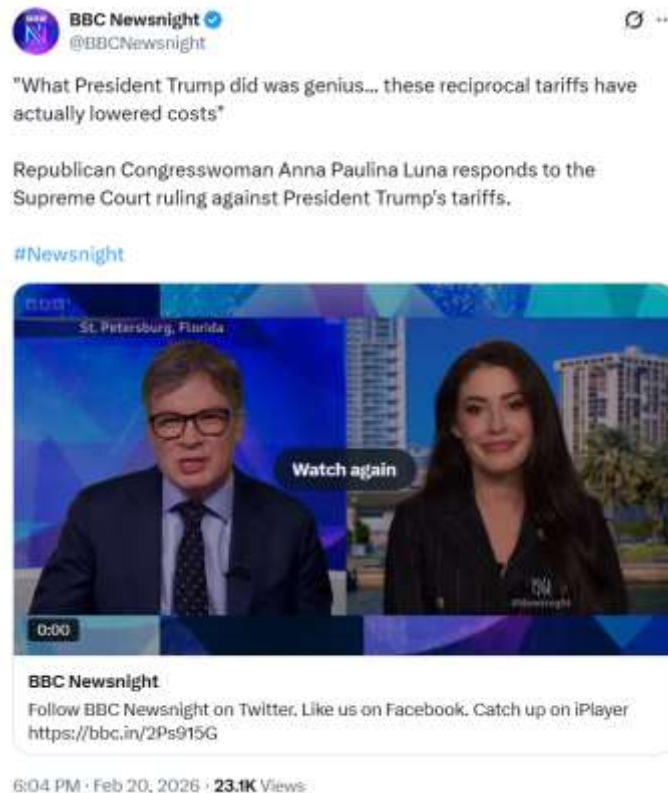
